1. Call to order

5. Minor variance application No. A08.2022 - 133 Marshall Heights, Township of Glenelg

5.1 Application No. A08.2022 - Becky Weltz and Chad Weltz

5.2 Planner L. Spencer - report minor variance application A08.2022

Planner Spencer reviewed her report noting that the subject lands are municipally identified as 133 Marshall Heights, south of the Town of Durham. The property is legally identified as lot 34; plan 16M29 in the geographic township of Glenelg. The purpose of the application is to vary the provisions of sections 6.1.4(ii) and 6.1.3 to permit a total floor area of 118 m² (1,270 ft²) whereas 92.9 m² (1,000 ft²) is permitted and a total height of 5.48 metres whereas 5.0 metres is permitted. The effect of which will permit the construction of an accessory structure. A single detached dwelling unit is also proposed for the subject lands and permit applications have been provided for both structures.

6.2 Planner L. Spencer - report consent to sever application No. B06. 2022

Planner Spencer reviewed her report noting that the property does not have a municipally identified address but is legally identified as part lot 26, concession 3 EGR in the geographic township of Glenelg.

The purpose of the application is to sever one (1) 20.7 hectare parcel for the purposes of a lot addition and retain one (1) 20.7 hectare rural parcel. The effect of which will leave a retained parcel of approximately 20.7 hectares and a newly enlarged parcel approximately 31.2 hectares in size.
