Subject:	SVCA WECI Funding

#### **Recommendations:**

THAT in consideration of staff report SVCA WECI Funding, council:

- 1. supports the Saugeen Valley Conservation Authority's application for Water and Erosion Control Infrastructure (WECI) funding for 50% of the following projects:
  - i. Durham Upper Dam Class EA up to \$30,000 total cost
  - ii. Neustadt Flood Control Works, Meux Creek up to \$400,000 total cost;
- directs staff to allocate 50% (\$15,000 for Durham Upper Dam EA and \$200,000 for Neustadt Flood Control Works) for West Grey's contribution to be funded from the General Capital Reserve.

## Highlights:

- SVCA staff attended the Jan. 17, 2023, council meeting to present their recommendations for applications under the WECI funding program.
- The projects being recommended are a Class EA for the Durham Upper Dam and Neustadt Flood Control Works Meux Creek.
- SVCA is estimating the total cost of the Durham Upper Dam EA to be \$30,000 with 50% funding from WECI and the remaining \$15,000 funded by West Grey.
- SVCA is estimating the total cost of the Neustadt Flood Control Works to be \$400,000 with 50% funding from WECI and the remaining \$200,000 funded by West Grey.
- The application deadline to apply for WECI funding is February 17, 2023

## **Previous Report/Authority:**

SVCA Report to Jan. 17, 2023, council meeting

#### Analysis:

SVCA recommended in their report to the January 17, 2023, council meeting that a class environmental assessment be completed on the Durham Upper Dam to determine what longer-term solutions could be used to address various public safety concerns.

SVCA also recommended in their January 17, 2023, report to council that the gabion basket wall in Meux Creek in Neustadt be rehabilitated.

The WECI grant submission period is from January 23 to February 17, 2023.

## **Financial Implications:**

West Grey's share of the projects can either be raised through the tax levy or it can be transferred from general capital reserves.

#### **Communication Plan:**

The council resolution would be forwarded to SVCA for inclusion with the WECI grant application.
