

Amendment # 1 Tripartite Tiered Emergency Response Agreement

This Amending Agreement is made this 1st day of May, 2023, in duplicate between:

The Corporation of the County of Grey

(referred to in this Agreement as “the County”),

-And-

The Corporation of the Municipality of Grey Highlands

(referred to in this Agreement as “Municipality 1”)

-And-

The Corporation of the Municipality of West Grey

(referred to in this Agreement as “Municipality 2”)

Whereas the County, Municipality 1 and Municipality 2 entered into a tripartite tiered emergency response agreement effective August 2, 2018, expiring August 1, 2023 (the ‘Principal Agreement’);

And Whereas the County, Municipality 1 and Municipality 2 have agreed to enter into an amending agreement to the Principal Agreement;

Now Therefore in consideration of the mutual covenants and agreements below and other good and valuable consideration, (the receipt and sufficiency of which is hereby acknowledged), the County, Municipality 1 and Municipality 2 agree as follows:

1.0 Amendments

1.1 Add clause 20.0 General as follows:

“20.0 General

20.1 the terms defined in the recitals shall have the same meaning as if repeated here at length.”

1.2 Remove clause 2.1 of the Principal Agreement.

1.3 Add clause 2.1 of the Principal Agreement as follows: “This agreement shall be effective on the date that it is signed by all parties and shall continue until June 30, 2028 (the “Term”), unless it is otherwise terminated as per section 10 of this Agreement.”

2.0 Remaining Terms

2.1 All remaining terms of the Principal Agreement remain unchanged and in full force for the full term unless changed by written amendment.

3.0 Counterparts

3.1 This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original and all of which, taken together shall constitute one and the same instrument. Counterparts may be transmitted by fax or in electronically scanned form. Parties transmitting by fax or electronically will also deliver the original counterpart to the other parties, but failure to do so does not invalidate this Agreement.
