4.1 7:05 pm: Sarah Cowley, Certified Health Executive, Sarah C Consulting and Barb Fendy, Director of Social Services, Grey County regarding Community Safety and Well-Being Planning for the Municipalities of Bruce and Grey

Sarah Cowley, Sarah C Consulting shared a presentation regarding Community Safety and Well-Being Planning (CSWBP) for the Municipalities of Bruce and Grey Counties. This plan is legislated under the Police Service Act. The presentation highlighted the partners who have been involved in the project, provided details on phase one and who, shared the priority areas of risk for action within the CSWBP for Bruce and Grey, explained key components of the Indicator Report and next steps, and outlined the plan for sustainability for the Bruce and Grey CSWBP. The Ontario CSWBP Framework includes social development, prevention, risk intervention, and incident response. The Bruce and Grey CSWBP model includes Champions, Multi-Sector Advisory Committee, Steering Committee, Coordinator, and Action Tables. The priority risk areas for Grey and Bruce are addiction/substance use, mental health, crime prevention, housing & homelessness, and poverty and income. Currently, the planning is in phase one.

4.2 7:20 pm: Allan Madden, CEO, South East Grey Community Health Centre (SEGCHC) regarding Grey Bruce Ontario Health Team Development

Allen Madden, CEO, South East Grey Community Health Centre shared a presentation on the development of Grey Bruce Ontario Health Team. Through legislation introduced by the Ontario Government in 2019, Ontario Health Teams (OHTs) are being introduced to provide a new way of organizing and delivering services in local communities. Under OHTs, health care providers will work as one coordinated team.

There are 40-50 healthcare agencies in Grey and Bruce. Grey Bruce Ontario Health Team's vision is to improve services offered across the system, OHTs will have one budget, and they would all be held accountable under one integrated scorecard. Seniors, mental health and addictions are have been identified as the first years of priorities.

CEO Madden explained how the Local Health Integrated Network (LHIN) is a centralized regional model that operates out of southwest Ontario. Currently through the LHIN, Bruce Grey doesn't have financial autonomy. The Grey Bruce Ontario Health Team would create local autonomy, therefore making the LHIN redundant.

There is a survey on the South East Grey Community Health Centre to gather data, which will assist in developing targets in the first year and beyond.

Stephanie Stewart, Manager of Community Transportation, Grey County, shared an update on the Grey Transit Route (GTR). In July 2019, Grey County received \$1.8 million to fund transportation in the region of Grey County. Transportation on Grey Road 4 is currently being funded by Grey County and is running alongside the other routes supported by the grant.

Currently the vehicles are not wheelchair accessible; however, Manager Stewart has been working with local and county accessibility committees. She confirmed that patrons will need to have transportation to the bus stops. Mobility devices may be stored at the back of the van.
