Ms. Hopkins commented on activities at existing aggregate pits and noted that noise, gravel, and dust are expected to increase if applications for an aggregate pit expansion and two new aggregate pits are approved.

Ms. Hopkins asked Council to consider the benefits of a balanced economy that was not focused so heavily on aggregate extraction.

4.2 Delegation from Judi Smelko Re: Gravel Mining in West Grey

Judi Smelko, resident and member of the Saugeen Preservation Society, provided a delegation on aggregate activities in Ontario and in West Grey.

Ms. Smelko asked Council to consider implementing an interim control bylaw to pause any zoning changes for proposed aggregate pits and requested that Council create new/updated policies related to aggregate extraction.

Deputy Mayor Hutchinson advised that proceeds of the fundraising event provided assistance for 75 families in West Grey, with additional support planned for distribution in February.

Councillor Hutchinson requested an update regarding frazil ice. The Chief Administrative Officer advised that the situation is being carefully monitored, and that Municipal staff are working with the Saugeen Valley Conservation Authority and local contractors to ensure all appropriate measures are being taken; six high-hoes worked continuously over several days to remove slush from the river, thus helping stabilize water levels and improve river conditions. CAO Harris thanked staff and local contractors who worked tirelessly to help prevent flooding.

Mayor Eccles thanked the Ayton Firefighters for a successful New Year's breakfast on January 1, 2025, noting that approximately 600 people were served.
