11.	Emit, cause or permit yelling, shouting, etc. at prohibited time	s. 11, Sched. A, 2	\$300.00
12.	Emit, cause or permit venting of steam	s. 11, Sched. A, 3	\$300.00
13.	Emit, cause or permit the operation of waste collection or refuse compacting equipment at prohibited time	s. 11, Sched. A, 4	\$500.00
14.	Emit, cause or permit the usage of property maintenance tools at prohibited time	s. 11, Sched. A, 5	\$300.00
15.	Emit, cause or permit the operation of construction equipment for domestic works at prohibited time	s. 11, Sched. A, 6	\$300.00
