



# Joint Notice of Public Open House

## Municipal Tree By-law Update and Grey County Forest Management By-law Update

**Public Open House: March 24, 2021 at 5:00pm - 6:30pm (Virtual - Online format)**

### What is being proposed?

The Town of The Blue Mountains is considering updating the current Municipal Tree Preservation By-law 2010-68. The County of Grey is also considering updates to the current County Forest Management By-law 4341-06.

This is a joint open house.

The intent of the Virtual Open House is to provide the public with information about existing regulations on tree cutting and forestry management. Town and County Staff will also gather public input and comment on how trees should be protected in the future.

Input received at the Virtual Open House will help to guide the scope and direction of any future changes to each respective by-law, including what areas of Town they should each apply to, and the appropriate approach for tree protection.
