#### 1. Call to order

Mayor Robinson called the meeting to order at 9:04 a.m.

Staff outlined how to join the meeting using Zoom meeting software or by telephone, as well as, how to contact staff for assistance for technical issues during the meeting.

# 4. Delegations / presentations

# 4.1 Alex Cook, West Grey resident - Road Allowance Access

Mr. Cook informed council that a public road allowance that his family uses to access Moss Conservation lands currently has deterrents put in place that block access to the road allowance, including a gate and barbed wire. Council directed staff to bring forward a report for council to address the matter.

Mayor Robinson thanked Mr. Cook for bringing the issue to the attention of council.

# 4.2 Genevieve Scott, Cuesta Planning Consultants Inc. - Proposed Consent & Access Via Concession 2 Road Allowance

Genevieve Scott, Cuesta Planning Consultants Inc. presented information about a proposed consent and possible access to the property in question from Concession 2 for their client Maria Mychalchuk. The Ministry of Transportation does not support access from the highway. Approximately 30 metres of unopened road allowance on Concession 2 will need to be opened. Ms. Scott requested that council give consideration to a limited or non-service agreement with the landowner regarding this portion of the road allowance upon approval of consent by committee of adjustment.

Mayor Robinson thanked Ms. Scott for the presentation.

#### 8. Comment period

Staff outlined the process for members of the public to participate in the comment period using Zoom meeting software or by telephone.

Clerk Scharback summarized comments received via email from Guy and Leonard Coulas, West Grey residents. The comments provided a brief history of the installation of the gate. It was identified that a large portion of the property around the road allowance is managed forest, that the road allowance is only clear for the first 300 feet and that the road allowance does not lead to Moss Lake Conservation Lands. An individual would need to trespass on private property to access the conservation lands.

Mayor Robinson advised that staff will bring a report regarding this matter to the April 20, 2021 council meeting. Council directed staff to reach out to Mr. Cook and inform him that everything will remain status quo until the issue is resolved.

Mayor Robinson informed that a letter was received from the Saugeen Valley Conservation Authority (SVCA) and Waster Resource Committee regarding the permanent closure of the walkway at the upper dam gate beginning on Oct 31, 2020. The closure was due to prevent theft and vandalism and to address health and safety concerns. The SVCA will be completing a public safety assessment to address potential hazards. Communications have been sent out and signs have been posted.

Deputy Mayor Hutchinson advised that due to a conflict the SVCA meeting to discuss the closure of the walkway at the upper dam has been postponed.

# 11.1.2 Guelph Eramosa Township re Municipal Freedom of Information and Protection of Privacy Act (MFIPPA) Reform

- 2. That MFIPPA be updated to address current and emerging technologies;
- 3. That MFIPPA regulate the need for consistent routine disclosure practices across institutions;
- 4. That the threshold for frivolous and/or vexatious actions be reviewed, and take into consideration the community and available resources in which it is applied;
- 5. That the threshold for frivolous and/or vexatious also consider the anonymity of requesters, their abusive nature and language in requests to ensure protection from harassment as provided for in Occupational Health and Safety Act:
- 6. That the application and scalability of fees be designed to ensure taxpayers are protected from persons abusing the access to information process;
- 7. That administrative practices implied or required under the Act, including those of the IPC, be reviewed and modernized;
- 8. That the integrity of the Act be maintained to protect personal privacy and transparent governments.

That this motion be forwarded to The Minister of Municipal Affairs and Housing and the Information and Privacy Commissioner of Ontario (IPC)

# 11.1.3 Town of Orangeville re Greenhouse Gas Emissions
