# 4.1.1 Jackie Pennings, Grey County Federation of Agriculture re the importance of agriculture to community at 6:05 p.m.

Dianne Booker, President, Grey County Federation of Agriculture provided a power point presentation regarding the Ontario Federation of Agriculture, OFA, and the Grey County Federation of Agriculture. She reviewed the roles and service to the agricultural communities of both organizations. She shared information demonstrating the importance and key roles of the agricultural sector in Grey County and across the province.
