

# Minutes Special Council meeting Municipality of West Grey Tuesday, March 30, 2021, 9 a.m. Virtual meeting

## 4.1 West Grey Police Board Chair Doug Townsend and Board Member Helen-Claire Tingling

West Grey Police Services Board Chair Doug Townsend and board member Helen-Claire Tingling presented the West Grey Police Services draft budget. Mr. Townsend reviewed the cost per capita and geographic area noting it is the lowest cost in the area, and the lowest number of officers per area. Member Tingling provided an overview of the increased calls for service and the necessary budget to provide appropriate policing levels for the community. They reviewed the proposed budget in detail. Mayor Robinson requested a recorded vote for the resolutions related to the Police Services Budget following the presentation.

Mayor Robinson passed the chair to Deputy Mayor Hutchinson at this time, 10:15 a.m. in order to speak to the proposed motion.

#### 6. Matters arising from the closed session

Mayor Robinson reported that in closed session council addressed matters pertaining to personal matters about an identifiable individual, including municipal or local board employees and direction was provided to staff. There is nothing further to report.

### 7. Staff reports

#### 7.1 Director of Finance/Treasurer, 2021 Budget Review continued

Director Mighton reviewed the draft budget. The following amendments were made:

The speed sign is included in operational budget using \$30,000 of modernization funding and can be removed from capital side, reducing capital by \$30,000.

The fire department work wear for three stations has been removed, reducing capital by \$17, 250.

The cost of financing the construction of the police services building in 2021 in the amount of \$300,000 was moved to 2022.

Funds in the amount of \$40,000 to reserves for an ice resurfacer were reduced to \$36,750 and modernization funds will be allocated to the ice resurfacer. \$40,000 will be required for this in 2022.

Landfill tipping fees will be increased from \$5.00 to \$10.00, for an estimated increase to revenues of \$53,085 per year, being \$26542.50 for the remainder of 2021.

Council conference and seminar amount was left at \$10,500, being \$1,500 per member each year.

The estimated growth will result in an increase to assessment of approximately \$186,000.

There is a \$62,000 reduction to the operational budget based on council's wage grid decision.

The above noted changes result in an increase of approximately 6% to the municipal portion of the tax levy, and an overall 3.57% tax levy increase, including county and education levies, being approximately \$39 on \$100,000 of assessment.

Proposed changes to landfill hours that would result in savings of approximately \$40,000 per year will be considered at the next budget meeting with an update on survey results.

Landfill costs for film, Styrofoam and clothing recycling as well as composting at landfills were discussed and will be included in a comprehensive landfill study.

Two student positions that were cut from the 2020 budget will be included again in 2021 for park maintenance.

The clerk will send out a doodle poll to determine a date for the next budget meeting.
