#### 1. Call to Order

Mayor Robinson called the meeting to order at 6:03 p.m. Staff reviewed the Zoom software and how to participate via Zoom or telephone.

## 4. Delegations/Presentations

# 4.1 Presentation - BM Ross and Associates Ltd: Lantz Bridge, Concession 2 WGR.

Ken Logtenberg P. Eng, B.M. Ross and Associates Limited, provided a presentation on the replacement project for the Lantz Bridge, Structure 28, located on Concession 2 WGR. He reviewed the condition of the bridge and noted that the municipality was successful in an application for Investing in Canada Infrastructure Program, (ICIP), funding in 2019. A Municipal Class Environmental Assessment, (MCEA), was completed in 2020. He provided a

summary of alternatives available, being do nothing, replace with a single lane bridge, or replace with a two lane structure. Doing nothing or replacing with a single lane bridge were deemed unacceptable options. Estimated costs and pros and cons for options to complete a two lane bridge were reviewed. Mr. Logtenberg advised that there will be a virtual public information session hosted by BM Ross to present information and address questions from the public on May 20, 2021 6:30 p.m. to 8 p.m. The link to attend the meeting will be available on the municipal website and has been provided in letters to concession 2 residents. Mr. Logtenberg also addressed questions of council, noting the criteria used to determine that a single lane bridge is not possible includes many factors such as traffic count, location, considering if it is part of overall transportation network, or for a seasonal location. Mayor Robinson thanked Mr. Logtenberg for his presentation.

# 4.2 Presentation - Triton Engineering Services Ltd: Rehabilitation of Garafraxa St. Bridge, Durham

Chris Clark P. Eng, Triton Engineering Services Limited, provided a presentation to update council on the Garafraxa Street Bridge, Durham, rehabilitation project. He reviewed the scope of the work, as well as the issues with the bridge railing which is currently sub-standard and will need to be upgraded based on a Canadian Highway Bridge Design Code new policy effective January 2019. This policy supersedes the previous engineers report. Mr. Clark reviewed various railing options. He addressed questions of council. Mayor Robinson thanked him for his presentation.

that staff be directed to send a letter indicating such support to the local MP, MPP, Federal Minister of Health, the CRTC and local area municipalities to indicate our support.
