1. Call to Order

Mayor Robinson called the meeting to order at 6:00 p.m. Staff reviewed instructions for members of the public to join and participate in the meeting via Zoom or telephone.

2. Moment of Reflection

Mayor Robinson called for a moment of reflection.

4. Delegations/Presentations

4.1 Alex Neuman - Durham Homecoming 2022

Mr. Alex Neuman, Chair of the Durham Homecoming 2022 Committee provided a review of the history of Durham and homecoming celebrations. He also reviewed a draft schedule of events planned for the

2022 homecoming. Mr. Neuman provided council with an overview of the draft budget and fundraising goals. Fundraising ideas include an accessible splash pad and a pavilion. The Committee is requesting that council appoint them as a committee of council, have the municipality provide financial support, insurance coverage, reduced rental fees, financial services and allow the committee to determine how profits will be distributed after the event.

Sue Papineau, resident, commented on the Parks and Garden Plan report, noting her dissatisfaction with the proposed plan to clean up the gardens and hoped to see a more comprehensive plan moving forward.

Marian Ratcliffe, resident, commented on item 10.1.2 noting that she is in favour of the recommendation to move forward with a dark sky policy and is disappointed with council's lack of support for environmental issues.

Marg Krauter, resident, commented on item 14, a notice of motion by Councillor Hamilton regarding training in Indigenous history and reconciliation, noting that this is not a priority for West Grey council and the cost and time should be considered. She also noted her dissatisfaction with staff reports.

Mayor Robinson advised that a report on concession 2 will be brought to a future meeting.

Bev Falco, resident, commented on item 10.1.2 regarding a dark sky policy stating that this is an issue that needs attention from council and staff.

Chris Palmer, resident, thanked staff and council for receiving his correspondence regarding a dark sky policy.

Whereas the report by the Truth and Reconciliation Commission of Canada contains 'Calls to Action' several of which are actionable by local governments including Call 57: "We call upon federal, provincial, territorial, and municipal governments to provide education to public servants on the history of Aboriginal peoples, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal—Crown relations. This will require skills-based training in intercultural competency, conflict resolution, human rights, and anti-racism."

Therefore be it resolved that the 2021 annual training program include education on the history of indigenous people.
