#### 1. Call to Order

#### 4.1 Presentation - Principles Integrity Periodic Report

Integrity commissioners Janice Atwood-Petrowski and Jeffrey Abrams from Principles Integrity provided an overview of their periodic report for April 1, 2018 to March 31, 2021, including information regarding the integrity commissioners role and West Grey code of conduct. Mr. Abrams shared that the Office of the Integrity Commissioner of Ontario is conducting a survey that

will initiate a provincial review, with the hope of a standardized province-wide integrity commissioner process.

Mayor Robinson thanked Ms. Atwood-Petrowski and Mr. Abrams for their presentation.

# 4.2 Delegation - Kim Wingrove, Grey County - Rockwood Terrace Lands Update

Kim Wingrove, Grey County CAO, and Randy Scherzer, Grey County Director of Planning & Development, provided an update regarding the redevelopment of Rockwood Terrace. They noted that there is a 2025 completion date for the Long-Term Care facility, and a proposal for a phased in "campus of care" community. Future discussions with West Grey council will include potential campus of care models, required investment, prioritizing and phasing. Grey County will work with West Grey regarding the future site plan application, lifting of the holding zone, building permits, and opportunities to efficiently service the site and future developments. The site plan and looping of services will also be shared and discussed.

Mayor Robinson thanked CAO Wingrove and Director Scherzer for their delegation.

# 4.3 Delegation - Jennifer Stephens, Saugeen Valley Conservation Authority- Durham Upper Dam Pedestrian Walkway

Jennifer Stephens, General Manager/Secretary Treasurer with Saugeen Valley Conservation Authority provided a power point presentation outlining the short-term repairs to the Durham upper dam and pedestrian walkway for completion in 2021, and the intention to investigate a long-term option for a pedestrian walkway and repairs to the upper and lower dams for implementation by 2026.
