#### Monthly Stats

May 2021 stats were provided to the Board and of note:

- motor vehicle collisions remain low.
- alarms are on increase and this is related to seasonal residents returning to cottages. -
- bail violations are on increase. Offenders being released under Bill C-75 are continuing to offend.
- drug charge down as legislatively only to charge for trafficking not simple possession
- fire calls up as Service assists with scene and traffic control
- Landlord and Tenant disputes have risen to 27 to date.
- MHART continues to be busy with 15 calls in May
- stolen vehicles down
- suspicious persons calls up with 12 logged in May
- the Calls for Service and Foot Patrol categories have been added at the end of the Monthly Stat Report

Discussion arose on the revolving door created with the Amendments to the Criminal Code under Bill C-75. Bail conditions are to be reasonable with release at earliest opportunity favoured if no risk to public safety. Implementation of these amendments was to modernize the courts and make them more efficient.

Chief stated that offenders are well aware of the changes and that the Service is seeing an increase in crimes and that they are becoming more violent.

H. Tingling asked that staff prepare a letter to be sent to other Police Boards and our member of provincial parliament asking for their support in lobbying for change with respect to bail release.
