



**The Corporation of the Municipality of West Grey  
Bylaw No. 60-2021**

Being a bylaw to provide for the drainage works in the Municipality of West Grey, in the County of Grey, being the Wright Municipal Drain 2021.

Whereas the requisite number of owners have petitioned the council of the Municipality of West Grey in the County of Grey in accordance with the provisions of the Drainage Act, 1990 requesting that the following lands and roads be drained by a drainage works known as the Wright Municipal Drain 2021, serving Parts of Lots 29 to 30, Concession 9, Parts of Lots 28 to 31, Concession 10 in the Municipality of West Grey, Former Township of Normanby, Grey County; and

Whereas the council of the Municipality of West Grey in the County of Grey has procured a report prepared by Dietrich Engineering Limited and the report is attached hereto and forms part of this bylaw; and

Whereas the estimated total cost of constructing the drainage works is \$145,058; and

Whereas the council is of the opinion that the drainage of the area is desirable.

Now therefore be it resolved that the council of the Corporation of the Municipality of West Grey, pursuant to the provisions of the Drainage Act, 1990, hereby enacts as follows:

1. That the report dated June 16, 2021 and attached hereto as Schedule "A" to this bylaw is hereby adopted and the drainage works as therein indicated and set forth is hereby authorized and shall be completed in accordance therewith.
2. The Corporation of the Municipality of West Grey may borrow on the credit of the corporation the amount of \$145,058 being the amount necessary for construction of the drainage works.
3. The Corporation of the Municipality of West Grey may issue debentures for the amount borrowed less the total amount of:
  - a. Grants received under Section 85 of the Drainage Act;
  - b. Commuted payments made in respect of the lands and roads assessed within the municipality;
  - c. Money paid under Section 61(3) of the Drainage Act;
  - d. Money assessed in and payable by another municipality.

Such debentures shall be made payable within five (5) years from the date of the debenture and shall bear interest at a rate not higher than the rate charged by the Ontario Municipal Improvement Corporation on the sale of such debenture.

4. A special equal annual rate sufficient to redeem the principal and interest on the debentures shall be levied upon the lands and roads as set forth in the attached Schedule "A", to be collected in the same manner and at the same time as other taxes are collected in each year for five years after the passing of the bylaw.



5. All assessments of \$1,000 or less are payable in the first year in which the assessment is imposed.
6. That this bylaw shall come into force on the passing there of and may be cited as the Wright Municipal Drain 2021.
