



## **The Corporation of the Municipality of West Grey**

### **Bylaw No. 68-2021**

Being a bylaw to dedicate lands as a public highway.

Whereas the Municipal Act, 2001, as amended, section 5(3) provides that a municipal power, including a municipality's capacity, rights, powers and privileges under section 9, shall be exercised by bylaw unless the municipality is specifically authorized to do otherwise; and

Whereas the Municipal Act, 2001, as amended, section 26 provides that all highways established by a bylaw of a municipality on or after January 1, 2003 are highways unless closed; and

Whereas the Municipal Act, 2001, as amended, section 31(2) provides that after January 1, 2003 land may only become a highway by virtue of a bylaw establishing the highway; and

Whereas the lands described as GS88219, being part of PIN No. 37234-0077 (LT), are directly adjacent to the southerly boundary of Part of Lot 16, Concession 13, Part 1, Reference Plan 17R-1498 in the Municipality of West Grey, formerly in the Township of Glenelg, being part of PIN No. 37234-0066 (R); and

Whereas the Council of the Corporation of the Municipality of West Grey deems it expedient and in the public interest to incorporate lands described as GS88219, affecting Part of Lot 16, Concession 13, in the Municipality of West Grey, formerly in the Township of Glenelg; being part of PIN 37234-0077 (LT); into the highway road system of the Municipality of West Grey;

Now therefore be it resolved that the Council of the Corporation of the Municipality of West Grey hereby enacts as follows:

1. That the Municipality of West Grey hereby dedicates the lands described in Instrument GS88219 as a public highway.
2. That West Grey Bylaw No. 57-2021 is hereby rescinded. Bylaw No. 57-2021 affected the lands described in Instrument GS88219 (part of PIN 37234-0077 (LT)) as well as Parts 1 and 2 on Reference Plan 17R-1498 (PIN 37234-0066 (R)).
3. That West Grey Bylaw No. 87-2004 is hereby rescinded. Bylaw No. 87-2004 affected Parts 1 and 2 on Reference Plan 17R-1498 (PIN 37234-0066 (R)).
4. That the CAO is hereby authorized to sign a Quit Claim Deed on behalf of the Municipality of West Grey wherein the municipality shall release all right, title and interest in Parts 1 and 2 on Plan 17R1498 (PIN 37234-0066 (R)).
5. That this bylaw shall come into force and take effect upon the date of final passing.

Read a first, second and third time and finally passed this 7<sup>th</sup> day of September, 2021.
