Saugeen Valley Conservation Authority (SVCA) staff has reviewed the above-noted application as per our delegated responsibility from the Province to represent provincial interests regarding natural hazards identified in Section 3.1 of the Provincial Policy Statement (PPS, 2020) and as a regulatory authority under Ontario Regulation 169/06 (SVCA's Development, Interference with Wetlands, and Alterations to Shorelines and Watercourses Regulation). SVCA staff has also provided comments as per our Memorandum of Agreement (MOA) with the Municipality of West Grey representing natural hazards, and natural heritage; and the application has also been reviewed through our role as a public body under the *Planning Act* as per our CA Member approved Environmental Planning and Regulations Policies Manual, amended October 16, 2018.

The purpose of the application is to implement a condition of provisional consent for files B15.2020, B16.2020, B17.2020, B18.2020, B19.2020, B20.2020 and B21.2020 by changing the zone symbol on the subject lands from A3 (restricted rural) and C2 (highway commercial) to R2 (medium density residential). The effect of which will satisfy a condition of provisional consent and permit the use of the lands for residential development.

Staff have received and reviewed the following documents submitted with this application:

- 1) Notice of Application and Public Meeting, dated October 12, 2021
- 2) Commissioned Application Form, dated October 7, 2020
- 3) Sketch for Zoning Schedule
- 4) Draft Zoning By-law

### **Recommendation**

SVCA staff find the application acceptable. The subject property does not contain any floodplains, watercourses, shorelines, wetlands, valley slopes or other environmental features of interest to SVCA or as per

Additionally, the property is not subject to Ontario Regulation 169/06, or to the policies of SVCA at this time, and as such, permission from the SVCA is not required.
