#### 1. Call to Order

Mayor Robinson called the meeting to order at 9:03 a.m.

On these grounds it is out of order and should not be considered by council.

Whereas the Chair of Saugeen Municipal Airport (SMA) Commission (SMAC) attended West Grey Council meeting on November 16, 2021, at the request of West Grey Council; Whereas the Chair of the SMA presented to West Grey Council that correspondence, unknown in nature, from the Ombudsman's Office had been received:

Whereas the Chair of the SMA on November 17, 2021 SMAC meeting revealed to SMAC that the SMAC lacks a procedural by-law;

Whereas West Grey Council requires accountability in governance and finance of our shared asset and partnerships;

Whereas our Municipal Representative to the Saugeen Municipal Airport has advised Council on December 7, 2021 that a draft Partnership Agreement and draft business plan has been prepared,

Whereas a SMA shareholder meeting has been requested to provide direction and mandate to the SMAC:

Whereas the bylaws, books, records and finances of the Saugeen Municipal Airport Corporation are to be regularly and properly kept;

Whereas the Chair knew or should have known that the Ombudsman was undertaking an investigation since March 2021.

Whereas the Ombudsman report of the Saugeen Municipal Airport was made public on December 9, 2021.

- Therefore West Grey Council requires a draft Partnership Agreement, with legal opinion from the preparer, forwarded to our CAO and Clerk and partner CAO's and Clerks; and
- 2. Therefore West Grey Council requires a draft Procedural By-law forwarded to our CAO and Clerk and partner CAO's and Clerks;
- 3. Therefore West Grey Council requires the Saugeen Municipal Airport maintain national COPA charter status;
- Therefore West Grey Council requires the Saugeen Municipal Airport draft business plan forwarded to our CAO and Clerk and partner CAO's and Clerks;
- 5. Therefore West Grey Council requires the corporate records filed with the Province to be updated, to reflect the current directors;
- Therefore West Grey Council requires a clause in the new draft
   Partnership Agreement that forecasts the sale of assets by one or
   more member
- 7. Therefore West Grey Council requires a copy of the fee schedule charged to all users, tenants, landowners and Municipalities, as amended and when updated;
- 8. Therefore West Grey Council requires a copy of all current and future litigation, Saugeen Municipal Airport is named in, be forwarded to the CAO and Clerk and partner CAO's and Clerks;
- 9. Therefore West Grey Council requires a copy of all offers of real and personal property for sale that the Saugeen Municipal Airport is named in, be forwarded to the CAO and Clerk and partner CAO's and Clerks;
- 10. Therefore Commission representation be swiftly amended to reflect 3 municipal representatives and up to 3 members at large, with dates of when they were appointed by resolution/by-law to commence their 2 year term;
- 11. Therefore SMAC will provide to West Grey CAO and Clerk one (1) week notice on all meetings, agenda 48 hours ahead of meeting, draft minutes within 5 days after any/all meetings, approved minutes within 5 days after any/all meetings; and
- 12. Therefore education from Transport Canada will be completed by the Saugeen Municipal Airport Commission on their responsibilities and role as Commission members.

- 13. Therefore all meetings will be in open session and available live and online with transcribed minutes of all meetings, unless properly closed under Section 239 of the Municipal Act,
- 14. Therefore all correspondence with the SMAC will be forwarded to West Grey CAO and Clerk and other Municipal
- 15. Therefore all closed session material from the SMAC will be shared with the Municipal Partner payors in closed session(s) by being forwarded to the CAO and Clerk of the municipal
