

Minutes Special Council meeting Municipality of West Grey Tuesday, January 4, 2022, 9 a.m. Virtual meeting

1. Call to order

Mayor Robinson called the meeting to order at 9:01 a.m.

Staff reviewed instructions for members of the public to participate via Zoom, telephone, and how to contact staff for assistance if disconnected. It was noted that this meeting will be livestreamed to the West Grey YouTube channel.

2. Moment of reflection

Mayor Robinson called for a moment of reflection.

3. Declaration of pecuniary interest and general nature thereof

4. Delegations / presentations

4.1 Presentation - Rakesh Sharma, P. Eng., GSS Engineering Consultants -Final water and wastewater 5 year capital

Rakesh Sharma, P. Eng. with GSS Engineering Consultants presented and reviewed the 5 year capital budget and schedule for water and wastewater he prepared. He noted that the existing private well in Durham, listed as item 2 under year 1, will require testing for water quality and security. He also noted

that the costs listed for water storage needs item 4 under year 1, item 3 under year 3 and item 1 under year 5 may be removed if the existing water storage tank has sufficient capacity. Additionally, the costs of sanitary sewer upgrades may be modified once an analysis of the sanitary sewers is complete as it will determine if replacement is required or remediation can take place.

Mr. Sharma confirmed there is sufficient water and wastewater capacity for the two new developments, Broos and Sunvale, and the Rockwood Terrace redevelopment.

Discussion included the possible increase to water capacity once repairs on the detected leaks in the water system, mainly in downtown Durham, are complete.

It was suggested that the water and wastewater 5 year capital budget report be revised annually to include upgrades to the systems and new information gathered through analysis.

Mayor Robinson thanked Mr. Sharma for his presentation.

5. Staff reports

5.1 Director of Finance/Treasurer

5.1.1 2022 Capital budget

Director Mighton reviewed and updated items included in the budget summary and on the operating budget and capital budget request form (BRF) indexes. She summarized that the proposed 2022 budget indicates a \$835,636, or 7.7%, tax levy increase, which includes the changes to the operating budget as approved at the November 30, 2021 special council meeting and adding in revenue from assessment growth of \$185,000.
