1. Call to order

Mayor Robinson called the meeting to order at 6:01 p.m.

4.1 Delegation - Chair Doug Townsend, West Grey Police Services Board

Doug Townsend, chair of West Grey Police Services Board, provided details of legislated and non-legislated services provided by the West Grey Police Service, and information regarding the police service budget increase.

Mr. Townsend noted the core police services as defined in section 4 of the Police Services Act, including details of revisions to the new Comprehensive Police Services Act not yet in place. He also noted that Ontario Regulation 3/99 of the Police Services Act, Adequacy and Effectiveness of Police Services, describes what a police service shall have, and that the West Grey Police Service continues to meet all standards listed in the document.

Mr. Townsend listed the numerous pieces of legislation that the police service is required to observe, and the various non-legislated community policing programs the police service provides West Grey.

Mr. Townsend provided a summary of the items that comprise the 10.3% budget increase for 2022.

Mayor Robinson thanked Mr. Townsend for his delegation.

Councillor Shea brought forward a point or order regarding Councillor Hutchinson's proposed motion to defer any further action on pursuing OPP costing, noting that it seems to introduce new information which could overturn a previous council decision.

4.2 Presentation - Jen Hayes and Graeme Wedge, MNP - Service delivery and operational review

Jen Hayes, Graeme Wedge and Jackson Potter from MNP provided a presentation to summarize the results of the service delivery and operational review they completed for West Grey.

The presentation outlined MNP's methodology used in conducting the review, their current state findings, and their recommendations.

The recommendations were categorized into four recommendation types: technology, organizational effectiveness, resource management, and strategy and performance management. The priority of each recommendation was identified as either immediate, medium-term, or long-term. Included in the presentation was a table illustrating the potential budgetary requirements for implementing the recommendations.

Councillor Hergert inquired about the criteria of the municipal comparators used to determine the financial benchmarking overview. Mr. Potter explained that MNP has a database of several municipalities across Ontario, some of the criteria used to search the database for municipalities with similarities include population, number of households, growth rates and seasonality. Mayor Robinson thanked Ms. Hayes, Mr. Wedge and Mr. Potter for their presentation.
