4. Update from committee chair, Doug Hutchinson

Doug led the committee on a walk from Riverside Park to Park Street. Along the walk Doug reported that he had an onsite meeting with Donna Lacey, from Saugeen Valley Conservation Authority, and Steve Ayerhart, from the Municipality of West Grey, on April 12, 2022 to discuss the current trail conditions. It was suggested that improvements could be made in the following areas:

-the trail entrance at Riverside Park be extended to the north (pictures 1 and 2),

- the trail area located to the east of the walking bridge at the lower dam have large stones installed along the east edge and then stone dust installed to level the area. (picture 3 and 4)
- two concrete blocks currently sitting beside a bench be moved to the parking lot at Riverside Park.
- that gates be installed in five locations: one set at the north end of Countess Street South, one set to the south of the current Saugeen Valley Conservation Area sign located to the west of South Street/Countess Street intersection, one set of gates on the north side of Park Street, one set of gates on the south side of Park Street and one set on the north side of Douglas Street.

5.1 The West Grey Trails committee recommends that council approves the purchase of 5 gates to be installed along the section of trail between Riverside Park and Douglas Street.

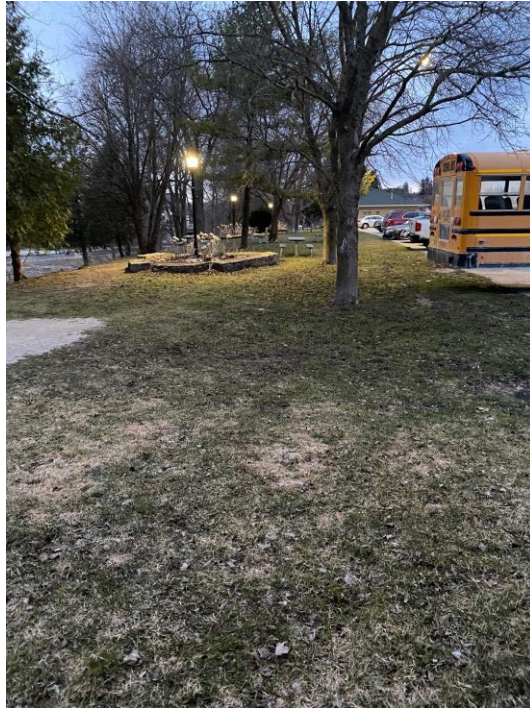
